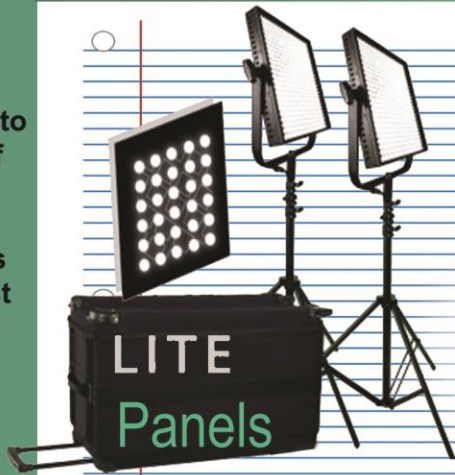

The criteria is as follows:

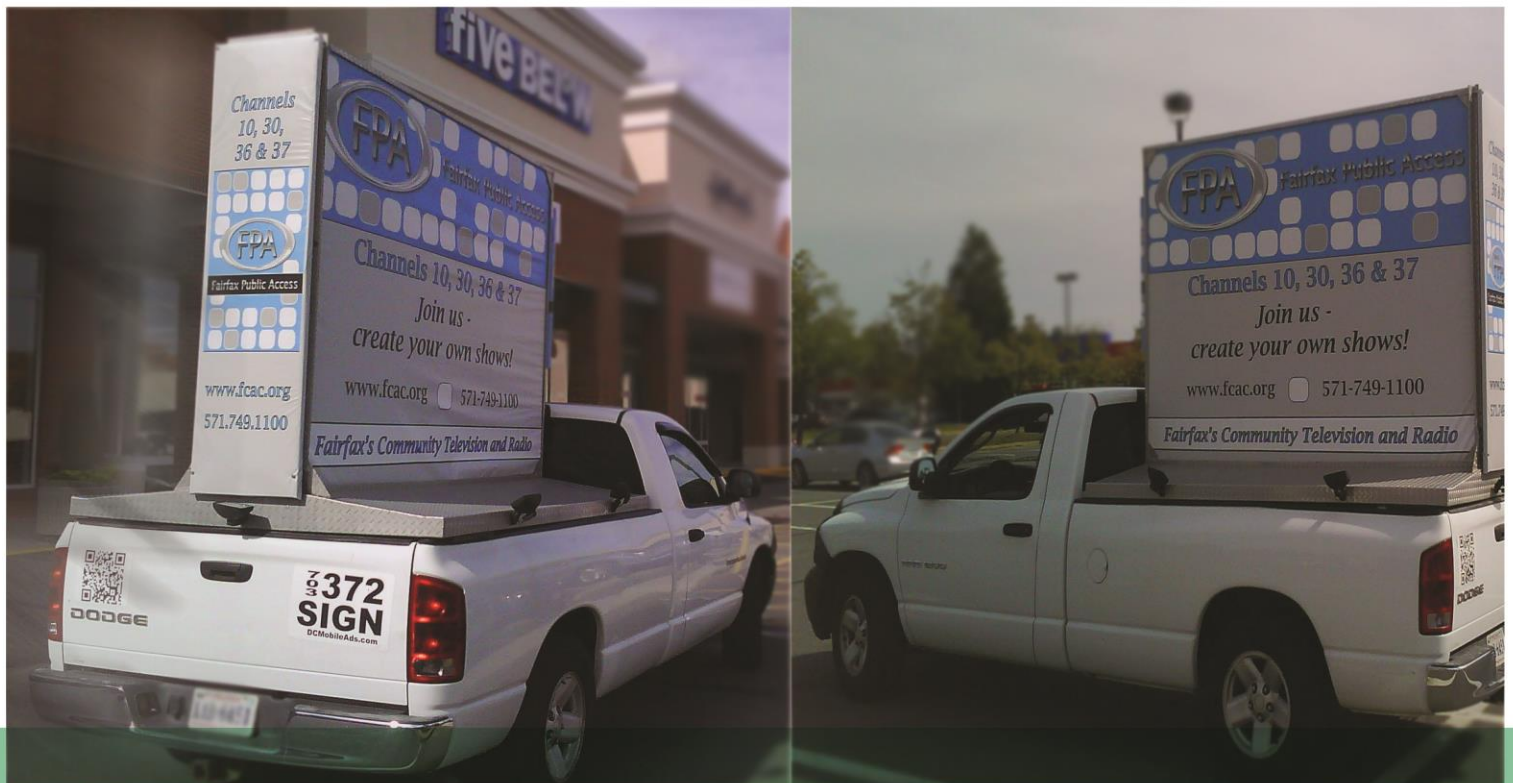
1. The show must be produced here.
