### FPA Institutes Television Volunteer Training Credit Program

Beginning Saturday, January 9, certified television volunteers will be able to earn credit toward FPA training classes when they volunteer their services to shows produced at or through Fairfax Public Access. This credit program, as envisioned by the Board of Directors, will allow volunteers to apply accumulated credits of up to 50% toward the cost of any future training course they wish to take. Any volunteer on a certified technical field or studio crew position (e.g. camera, audio, directing, etc.) can earn a \$ 20.00 credit that will be valid for one year from the date of the production, providing that they have filled out and submitted a volunteer form within 24 hours of their volunteer work, and that the form has been signed by the producer of record for the program and verified by the Equipment Room or Training Dept. staff. Producers cannot earn credits for their own productions, but may claim credits for volunteering on others'.

While credits can be applied toward 50% of the cost of the class, at least one-half of any credits used must come from volunteering on a show that is less than 4 years old, based on their initial proposal date. All 50% can be comprised of programs within the last four years, but only half of that 50% (25% of the class cost) can come from older shows. Volunteers must be certified and have completed any volunteer requirements before they will be allowed to earn credits toward future classes. When registering for a class using credits, the training department can only use credits earned and recorded in the database up to that date, and only credits that have been earned in the previous one-year period. Credits older than one year will be marked invalid and void for use.

To find out which programs currently in production are considered "old" or "new", volunteers can consult the yellow "Active Producers List", copies of which are found at the Equipment Room or with the Training Dept. Volunteers can also be added to the green "Volunteer List" and e-mail list group. Anyone who would like to be added to either list can contact Jay Erausquin at 571-749-1102, and will be included in the next listing update.

Volunteerism is the life blood of Fairfax Public Access, and with this program we hope that not only will our volunteers be able to further their training at reduced rates, but that our producers, especially new ones, might also have an easier time finding collaborators.

# Year-End Push for TV Programming

Hours of television production submitted have grown steadily over the past number of years, from 1,607.5 hours in calendar year 2006 to 2,265.5 hours for 2008. As of this date, we are only 42 hours away from tying last year's output, so for the last two weeks of this year, let's get busy! If you've got any shows finished, then make a point to get them turned in before the end of the year, or if you're close to completing a project, take a little extra time amidst the holidays and see if you can finish it up and submit it. The number of hours of programming we receive and air goes toward showing the public the value and importance of our mission at FPA, as well as allowing our viewers to see and hear valuable information from within their own community they are unlikely to find anywhere else. Help us continue our trend, setting a new high for 2009, and let's see if we can hit 2,500 for 2010!

### Steve Vlahovich: Aug. 10, 1920 - Oct. 27, 2009

Steve Vlahovich, volunteer producer and cameraman at Fairfax Public Access for more than twenty years, died of pneumonia Tuesday evening, October 27, 2009, at Sleepy Hollow Manor Nursing Home in Annandale after battling several illnesses over the past three years.

A native of Cleveland, OH, Steve was a Marine combat photographer during World War II, first deployed to the South Pacific and later reassigned to the Office of Strategic Services (OSS) in the China / Burma / India theatre, where he served in the Field Photographic Unit headed by Hollywood director John Ford. He was one of a group that parachuted onto Hainan Island to ensure the safety of British prisoners of war after the defeat of the Japanese. He photographed the surrender of the Japanese to the British in Hong Kong. During a brief post-war period when he worked as a civilian photographer, two of his photographs were published in the National Geographic.

On retiring from a career with the John Hancock Insurance Company, Steve became a volunteer producer and cameraman at Fairfax Public Access, Channel 10. He produced numerous individual programs, worked as a cameraman for others producers, and produced two long-running series of interest to the community, "Alternative Medicine" and "Photographers of Northern Virginia". He spent a part of almost every day at the studio.

He is survived by a daughter, Sharon Shields of Odenton, MD, a son, Stjepan Vlahovich of Columbus OH, a grand-daughter, three great-grand-children, and a great-great-granddaughter. Steve's ashes will be placed in the columbarium at Arlington Cemetery sometime this spring. Expressions of sympathy to Steve's family may be sent to his son.

Work continues on Master Control, with racks and consoles now in place. Upon receipt of the routing system in January, it is estimated that the upgrade will be completed by February 1. This upgrade now provides FPA with the latest in state-of-the art digital technology in a modular system, replacing analog components that in some cases were over twenty years old and prone to glitches or occasional transmission disruptions. With the upgrades and the complete re-wiring in place, the centralized system will provide greater reliability, use less energy, and put us in a position to allow for future expansion or improvements in technology as they arise. It will also make it possible to re-fit and rewire the studios at a later date to bring them up to current technical standards.
